2. Wal derfyn eiddo Mrs Bown. O ganlyniad i amgylchiadau anrhagweledig nid oedd y gwaith ar drwsio'r wal wedi'i gychwyn. Cadarnhaodd Mr Veevers y byddai'r gwaith yn cychwyn yn fuan iawn.

PRESNTATION: Mr Brian Jones, Isle of Anglesey County Council's Co-ordinator Older People's Strategy and Ms Luned Edwards were welcomed to the meeting. A presentation on the strategy and the "Building Communities" scheme was given by Mr B Jones and Ms Edwards. The Vice Chairman thanked both, and asked the Clerk to supply the information requested regarding local organisations to Ms Edwards.

MATTERS ARISING:

1. Village Clock. Mr N Williams, the caretaker, was present at the meeting and expressed his concerns regarding the water entering the clock. It was decided that Mr Williams seek the advice of Mr Malcolm Jones, a local electrician on the situation. The vice chairman thanked Mr Williams for attending the meeting.

2. Boundary wall at Mrs Bown's property. Due to unforeseen circumstances, the work of repairing the wall had not been commenced. Mr Veevers confirmed that work on the wall would commence shortly.
