TREWALCHMAI COMMUNITY COUNCIL MEETING 07/11/2016

Apologies: Apologies for their absence was received from: Councillor R G Parry, Mrs M Price (Clerk), Ms M E Evans, Mrs S Roberts. In the absence of the Clerk the minutes were recorded by Mrs S Jones.

Minutes: Minutes of the meeting held on 10/10/16 were accepted as a true record of the meeting.

Matters arising:

- (a) Village clock. A report confirming the estimate of £4794 for re-pointing the cement on the clock was received from Indpendent Memorial Inspection company. It is not necessary to repoint the whole clock. The Clerk and Mrs E Jones had met with the company. An aural report was given by Mrs E Jones confirming that the company had stated that the dampness inside the clock did not pose any danger to the electricity supply. Much of the dampness enters the clock from the plinth above the memorial tablets. The company will undertake the work as soon as any danger of frost has passed. The owner of Tŷ Newydd has given the company his permission to put their cherry picker inside his curtilage this will save on the cost of having to erect scaffolding around the clock. Mrs Mrs H Williams requested a copy of the report in order to share the information with the clock caretaker. This was agreed to. Mrs E Jones was thanked for her feedback.
- (b) Pendref footpath: No information to hand.
- (c) External Audit: Letter informing us that they are not able to supply their invoice at present this was received for information. The Clerk's reponse to the External Auditor's letter was read out in which she made many further observations challenging their findings.
- (d) Contract of employment: Copy had not arrived nothing to report.
- (e) Remembrance Sunday: Confirmation from the Police that there will be Police presence at the clock to stop the traffic during the two minute silence. The caretaker was requested to ensurse that the clock was on the right time (as near as possible) on this day. The caretaker requested permission to purchase small locks and plastic binders in order to secure the stand that holds the wreaths to the clock.
- (f) Gate at the Church public footpath: An email from Anglesey Council was received confirming that they will undertake the task of repairing the spring on the gate.
