6.2	Cyng N Evans Prydlesi Cae Chwarae a Chae Peldroed – Ebst oddi wrth y Cyng Evans at y Cyngor Cymuned: <i>Yn dilyn cyfarfod o Hyb Cymunedol Gwalchmai gofynwyd imi holi y Cyngor Cymuned a'r Cyngor Sir beth yw'r sefyllfa o ran cytundebau (lease) y maes chwarae a'r cael pel droed yng Ngwalchmai?</i> <i>Y rheswm am y cwestiwn ydi am fod yr Hyb Cymunedol yn awyddus ceisio am grantiau i wella y cyfleusterau yma ond ar ddeall nad oes modd gwneud hynny gan mai eiddo y cyngor cymuned ydyn nhw ac mai dim ond 8 mlynedd yw'r lease. Mae angen 20 mlynedd o lease er mwyn gallu ceisio am grantiau gwella.</i> <i>Y cais yn syml felly ydi a oes modd i cyngor bro Trewalchmai ofyn i'r cyngor sir am ymestyn y lease i 20 mlynedd er mwyn sicrhau y ddau safle i'r dyfodol ac i allu bod mewn sefyllfa i geisio am grantiau i wella a datblygu y safleoedd. Gofynnwyd i'r Clerc gysylltu gyda'r Cyngor Sir i ofyn 1 A fydd gofyn i'r Cyngor Cymuned dalu rhent ôl-ddyddiedig? 2 A ellir terfynu'r brydles heb unrhyw gosb?</i> Llofnod Cadeirydd Dyddiad 04.07.22	Cllr N Evans Leases Playing Field and Football Field – Email from Cllr Evans to the Community Council: <i>Following a meeting of the Gwalchmai Community Hub I was asked to ask the Community Council and the County Council what the situation is regarding the lease of the playing field and the football facility at Gwalchmai?</i> <i>The reason for the question is because the Community Hub is keen to apply for grants to improve these facilities but understand that it is not possible to do so as they are owned by the community council and the lease is only 8 years. 20 years of lease is required to be able to apply for improvement grants.</i> <i>The application therefore is simply whether Trewalchmai community council can ask the county council to extend the lease to 20 years in order to secure both sites in the future and to be in a position to apply for grants for improvement and development. the sites. Confirmation of the situation and procedure is likely to be required from Anglesey Council's Legal Department, but I would prefer that this be done through the community council than for me to inquire as a county councillor in order to be completely open and that everyone is part of the discussion.</i> The Clerk was asked to contact the County Council to ask 1 Will the Signature Chairman Date 04.07.22
