4.1	Gorlif o ddŵr Bragdy - New Haven. Mae'r Cyngor Sir wedi hysbysu'r Cyngorydd N Evans y bydd Dŵr Cymru yn ymchwilio i'r mater.	Overflow of water Bragdy - New Haven. Cllr N Evans has been advised by the County Council that Dwr Cymru will be investigating the matter.
4.2	Prydlesi Caeau Chwarae a Phêl-droed Mae'r Cyngor Sir bellach wedi cynnig codi'r rhent uwch am y cae pêl-droed o ddyddiad cychwyn y brydles newydd. Cytunodd yr Aelodau i hyn ynghyd â thalu'r ffioedd cyfreithiol o £679.00. Bydd y Clerc yn hysbysu'r Cyngor Sir. Hefyd gofynnwyd i'r Clerc ysgrifennu at y Clwb Pêl-droed i gadarnhau y gallant barhau i ddefnyddio'r cae am 5 mlynedd o ddyddiad y brydles newydd. Bydd y mater yn cael ei adolygu gan y Cyngor Cymuned ymhen 5 mlynedd pan fydd y rhent sy'n daladwy i'r Cyngor Sir yn cael ei adolygu. Gofynnwyd i'r Clerc ofyn am gopi o brydles y Cae Chwarae oddi wrth y Cyngor Sir.	Leases of Playing and Football Fields The County Council have now offered to charge the increased rent for the football field from the start date of the new lease. Members agreed to this together with paying the legal fees of £679.00. The Clerk will advise the County Council. The Clerk was also asked to write to the Football Club to confirm that they can continue to use the field for 5 years from the date of the new lease. The matter will be reviewed by the Community Council in 5 years when the rent payable to the County Council is due for review. The Clerk was asked to request a copy of the Playing Field lease from the County Council.

Yn seiliedig ar y cyfartaledd presennol o 4 claddedigaeth pob blwyddyn, dylai’r darn o dir fod yn ddigon am tua 60 mlynedd. Cytunwyd bod y Clerc yn cysylltu â pherchnogion y tir l gadarnhau diddordeb y cyngor mewn prynu’r tir ac l ddatgan y bydd y cyngor yn ystyried talu eu ffioedd cyfreithiol – cost rhyddhau’r gweithredoedd, y Gofrestrfa Tir a thaliadau terfyn ayb. Bydd hefyd yn gofyn am amcangyfrif o’u costau. Cynigiwyd gan y Cyng. O Williams ac eiliwyd gan y Cyng H N Evans.</p>	<p>St Morhaiarn cemetery – The Chairman Cllr S Jones has spoken to the owners of the land which is available to the council. The land is 0.2 of an acre, 745 meters square. Based on the current average of 4 burials each year, the piece of land should be enough for around 60 years. It was agreed that the Clerk contact the owners of the land confirming the council’s interest in purchasing the land and to state that the council will consider paying their legal fees – cost to release the deeds, Land Registry and boundary charges etc. He will also ask for an estimate of their costs. This was proposed by Cllr O Williams and seconded by Cllr H N Evans.</p>
